## Proceedings of the 36th Annual General Meeting held on 12th July, 2023

## Summary of proceedings of the 36th Annual General Meeting

The 36th Annual General Meeting (AGM) of the Members of Agro Tech Foods Limited was convened at 4.30 p.m. (IST) on Wednesday, 12th July, 2023 through video conference.
